


NF-κB p65 Ab



Application:	WB 1:500-1:2000, IHC 1:50-1:200, IF/ICC 1:200, IP *The optimal dilutions should be determined by the end user.	
Reactivity:	Human,Mouse,Rat	
Storage:	Rabbit IgG in phosphate buffered saline , pH 7.4, 150mM NaCl, 0.02% sodium azide and 50% glycerol. Store at -20 °C. Stable for 12 months from date of receipt.	
Purification:	The antiserum was purified by peptide affinity chromatography using SulfoLink™ Coupling Resin (Thermo Fisher Scientific).	
Immunogen:	A synthesized peptide derived from human NF-κB p65, corresponding to a region within the internal amino acids.	
Uniprot:	Q04206	
Description:	NFKB1 (MIM 164011) or NFKB2 (MIM 164012) is bound to REL (MIM 164910), RELA, or RELB (MIM 604758) to form the NFKB complex. The p50 (NFKB1)/p65 (RELA) heterodimer is the most abundant form of NFKB. The NFKB complex is inhibited by I-κappa-B proteins (NFKBIA, MIM 164008 or NFKBIB, MIM 604495), which inactivate NFKB by trapping it in the cytoplasm.	



Western blot analysis of extracts from various samples, using NF-κB p65 Ab.

- Lane 1: Pc12, treated with blocking peptide;
- Lane 2: Pc12;
- Lane 3: HepG2 cells.



AF6387 staining A549 cells by IF/ICC. The samples were fixed with PFA and permeabilized in 0.1% Triton X-100, then blocked in 10% serum for 45 minutes at 25°C. Samples were then incubated with primary Ab(AF6387) and mouse anti-beta tubulin Ab(T0023) for 1 hour at 37°C. An AlexaFluor594 conjugated goat anti-rabbit IgG(H+L) Ab(Red) and an AlexaFluor488 conjugated goat anti-mouse IgG(H+L) Ab(Green) were used as the secondary Ab.

The nuclear counter stain is DAPI(blue).

IMPORTANT: For western blot, incubate membrane with diluted primary Ab
